# **Reference Architecture Guide**

Use this reference architecture guide to design your implementation of Hitachi Solution for the SAP HANA platform using a converged solution for VMware vSphere. This scalable, converged infrastructure uses Hitachi Advanced Server HA820 G3 with a Hitachi storage system certified as SAP HANA enterprise storage. Hitachi Virtual Storage Platform E1090 is used as an example in this guide, but you can use other certified storage from Hitachi.

SAP HANA tailored datacenter integration (TDI) offers great flexibility for SAP business solutions in production and non-production environments. This can be in bare metal or virtualized environments.

Hitachi Solution for SAP HANA with Intel Xeon scalable processors running on VMware vSphere follows the SAP HANA TDI guidelines. The supported VMWare ESXi version for SAP HANA can be found in <u>SAP Note 2652670</u> (SAP user credentials required). It offers the power of SAP HANA while benefiting from the flexibility of a virtualized environment. It is ready to plug into your network to provide real-time access to operational data inside SAP HANA in your software-defined data center.

**Note:** Testing of this configuration was in a lab environment. Many factors affect production environments beyond prediction or duplication in a lab environment. Follow the recommended practice of conducting proof-of-concept testing for acceptable results in a non-production, isolated test environment that otherwise matches your production environment before your production implementation of this solution.

# **Solution overview**

This solution uses the Hitachi Advanced Server HA820 G3 and directly attached Hitachi Virtual Storage Platform E1090.

Implement and configure VMware following VMware and SAP best practices to guarantee best performance for SAP HANA running on a single or multiple virtual machine deployment.

Hitachi Advanced Server HA820 G3 is certified as a scale-up appliance in various configurations running SUSE Linux Enterprise Server (SLES) for SAP Applications or Red Hat Enterprise Linux (HREL). For more details, see the <u>Certified and Supported SAP HANA</u> <u>Hardware Directory</u>.

The following were tested:

- Full socket for one VM installed with SLES and one VM installed with RHEL
- Half socket for two VM SLES and two VM RHEL

VMware has certified vSphere 8.0u1a on Intel Sapphire Rapids processors for virtualized SAP HANA deployments. See <u>SAP Note 3372365</u> (SAP user credentials required).

# **Solution elements**

The converged infrastructure stack of Hitachi Advanced Server for SAP HANA follows the rules of SAP HANA TDI for virtualized environments. Leverage the flexibility of SAP HANA TDI for setups with multiple servers in a single environment using one SAP HANA-certified Hitachi enterprise storage system. This enables consolidated landscapes that guarantee equal performance and reliability as in bare metal appliances.

#### Hardware elements

This reference architecture guide uses Hitachi Advanced Server HA820 G3 for running VMware vSphere to host SAP HANA. It also uses Hitachi Virtual Storage Platform E1090 as persistent storage, although you can substitute other members of the Virtual Storage Platform G or the Virtual Storage Platform F series family if you have different needs.





# Network architecture configuration

Connect the 1 GbE management port on Hitachi Advanced Server HA820 G3 to a Cisco Nexus 92348, or to any other external 1 GbE switch for management connectivity.

Reference Architecture Guide

Make the following 25 GbE network connections for the client network setup for ESXi host and virtual machines for the uplink network:

- Connect the following to Cisco Nexus 93180YC-FX/FX3 switches or to any other external switches: Port 1 of dual port Intel E810-XXVDA2 2-port 25 GbE Network Adapter on PCIe\_Slot1.
- Port 1 of dual port Intel E810-XXVDA2 2-port 25 GbE Network Adapter on PCIe\_Slot4.
- Configure the corresponding two ports at the VMware ESXi level as uplinks in the virtual standard switch (VSS). Configure both vmnics as active. Use these two ports as the management network for the ESXi node as well as the network for the guest operating system. This acts as the client network for the SAP HANA node.
- At installation, the field engineer from Hitachi Vantara works with your VMware vCenter administrator to convert, merge, and migrate the VSS to your existing or new virtual distributed switch.
- Optional At this point, to speed up detecting corrupted connections, configure external switch ports with a port channel set to active/active as well as setting the LACP timeout value to short. On VDS, use vLAGs instead of uplinks.

If additional 25 GbE network connections are needed, connect Port 2 of both 25 GbE Intel E810-XXVDA2 PCIe cards to the Cisco Nexus 93180YC-FX/FX3 switches or to any other external switches.


Configure the external switch ports with a short LACP timeout value to speed up detecting corrupted connections.

Configure PCIE Slot 1 and Slot 4 of the primary port as uplinks in the VSS. PCIE Slot 1 and Slot 4 secondary ports (port 2) can be used as you want, such as in the following examples:

- Extra management kernel ports
- Extra virtual machine traffic
- VMware vSphere vMotion
- Backup
- SAP HANA System Replication

**Note:** The ESXi kernel network and virtual machine traffic can be on the same network switch or on separate network switches. It depends on the network environment.

### Storage architecture

The following is a list of the storage architecture and configuration for this solution:

- ESXi operating system boot configuration
- Hitachi VSP storage (VSP E1090) setup and configuration
- Parity group, RAID, and LUN configuration
- Virtual machine datastore configuration

#### ESXi operating system boot configuration

This solution configuration requires NS204i-u mirrored M.2 NVMe SSD for booting. It uses two 480 GB SSDs as a RAID 1 mirrored operating system volume to host the hypervisor.

#### Hitachi VSP storage (VSP E1090) setup and configuration

For the vHANA TDI model, the following storage components are needed to set up configuration for SAP HANA using Hitachi Virtual Storage Platform (VSP) storage for this solution.

The storage configuration for the SAP HANA node needs the following for different sizes:

- Local storage for OS boot
- ESXi volume (OS) NS204i-u mirrored M.2 SSD

The following storage components are required to implement a scale-up SAP HANA system with Hitachi Advanced Server HA820 G3 using external storage:

- 2 × HPE SN1610E 32 Gb 2p Fibre Channel PCIe HBA cards
  - Port 0 of HBA on Primary Riser Slot3
  - Port 1 of HBA on Primary Riser Slot3
  - Port 0 of HBA on Secondary Riser Slot6
  - Port 1 of HBA on Secondary Riser Slot6
- 1 Hitachi Virtual Storage Platform G/E series storage with storage drive box trays (DBS/ DBN)

The following are mandatory for the external storage option with direct connection between Hitachi Virtual Storage Platform and the SN1610E 32 Gb HBA on Hitachi Advanced Server HA820 G3:

- Enable Host Mode Option 02, Host Mode Option 94, and Host Mode Option 109 for the corresponding storage port connected with the server.
- Host Mode Option 109 This option fixes a SAN boot issue, when the system cannot find the Boot LUN after a restart.
- Host Mode Option 94 This option is mandatory for direct connection between the Hitachi Virtual Storage Platform and the SN1610E 32 Gb HBA. If this mode is not set, then SAN storage cannot be identified from the SN1610E 32 Gb HBA.
- Host Mode Option 02 (Optional) This option is recommended when the system uses test-unit-ready (TUR) for path\_checker in the /etc/multipath.conf file. This mode is typically used for fencing technology.

An example configuration for port properties with Hitachi Virtual Storage Platform is listed in the following table.

#### Parity group, RAID, and LUN configuration

This reference architecture uses a dynamic provisioning pool design for the storage layout that ensures maximum utilization and optimization at a lower cost for Hitachi Solution for SAP HANA using VMware vSphere.

This is the configuration of parity groups, RAID level, and LUNs. Use two dynamic provisioning pools with the specific parity groups and LDEV assignment listed in the following table for the storage layout.

This solution uses a dynamic provisioning pool (HDP) design for the storage layout.

Two pools are used to provide storage and throughput for all supported storage sizes:

- NS204i-u mirrored M.2 NVMe SSD is used for ESXi OS boot.
- Pool 0 is used to create virtual volumes (vVols) for OS, data, and shared binaries of virtual machines. Additional RAID groups and pool volumes can be added to increase the size of Pool 0 to support higher memory configurations.
- Pool 1 is used to create virtual volumes for the logging of virtual machines.
- Use thin provisioning to leverage the benefits of automatic performance optimization and storage space savings across pools of virtual capacity.

#### Virtual machine datastore configuration

The ESXi installer from Hitachi Vantara automatically creates datastores during installation. The following are details of created datastore examples tested in the lab environment.

### VMware vSphere configuration

This section describes the configuration of the VMware ESXi server, SAP requirements, and possible virtual machine configurations.

Note: The ESXi Side-Channel-Aware Scheduler patch does not allow the usage of more than one thread per physical CPU core. This limits the number of vCPUs available on a system. It can impact performance on existing systems and sizing of new systems.

For the SAP HANA workload in the virtual machines, SAP does not allow overcommitting CPU resources. Take this into account when sizing virtual machines and determining the required compute hardware resources.

The following table lists the minimum and maximum sizes for virtual machines running an SAP HANA workload.

Configuration	Size
Minimum virtual machine size	.5 socket CPU with at least 60 physical cores (60 vCPUs with hyperthreading) and 128 GB RAM
Maximum virtual machine size	Depends on CPU architecture
Sub-socket virtual machine sizes	0.5 socket No support for virtual machines with 1.5 sockets, 2.5 sockets, and so forth.
Full-socket virtual machine sizes	1 or 2 socket
Maximum number of virtual machines	2 virtual machine 2-socket server (Full socket) 4 virtual machine 2-socket server (Half socket)

**Note:** Currently half socket (Numa node sharing VM) is not supported for Sapphire Rapid servers yet according to <u>SAP Note 3372365</u>. We have tested half socket VMs in our lab environment and the half socket VMs are working as expected.

These are the SAP general sizing guidelines for virtualized environments with respect to storage, CPU, and memory requirements of SAP HANA.

When creating single or multi-virtual machine environments on a VMware ESXi server, some memory must be reserved for the ESXi server itself. Do not assign all available physical memory to the virtual machines.

**Note:** According to VMware's guidance, this memory overhead can be between 0.5% and a more conservative 3%. For example, on a Hitachi Advanced Server HA820 G3 with 1024 GB of RAM, assign up to 993 GB to virtual machines, after reserving 3% memory for ESXi host.

#### ESXi operating system boot configuration

This solution configuration requires NS204i-u mirrored M.2 NVMe SSD for booting. It uses two 480 GB SSD as a RAID 1 mirrored operating system volume to host the hypervisor.

#### Activate round robin multipathing policy

Using the round robin multipathing policy allows the configuration of multiple I/O paths between the server and the Hitachi Virtual Storage Platform E-series system. Round-robin aggregates all physical I/O paths into a single logical path, providing high availability and load balancing for the block devices. The LUNs are always available unless all four paths fail.

Use the round robin multipathing policy for the following I/O paths:

- ESXi operating system on local NVMe SSD
- SAP HANA server operating system LUN
- SAP HANA data volume LUN
- SAP HANA log volume LUN
- SAP HANA shared volume LUN

#### Virtual machine configuration parameters

VMware releases best practices for configuring the VMware ESXi server when running an SAP HANA workload that results from the certification together with SAP to ensure that all performance requirements for SAP HANA are met.

When provisioning virtual machines for SAP HANA, make sure to use hyperthreads on fewer NUMA nodes instead of only physical CPU cores spread over multiple NUMA nodes.

Also, add or change the parameters on the virtual machines as listed below.

#### Multiple virtual machine configurations

When running this solution in a single virtual machine configuration, a Hitachi Advanced Server HA820 G3 with 2 CPUs provides enough resources to run a virtual machine with the maximum possible 240 vCPUs.

Depending on the number of virtual machines as well as the requirements of the SAP HANA installation inside these virtual machines, further storage resources can become necessary. Contact your Hitachi Vantara account team to size storage for all SAP HANA-certified enterprise storage units.

Sizing is available for SSD drives, and Hitachi Accelerated Flash devices for the maximum number of SAP HANA nodes in the <u>SAP HANA Certified Hardware Directory</u>. For virtualized environments, one virtual machine counts as one SAP HANA node, according to SAP requirements.

In a single server environment, the maximum number of virtual machines is 2 when using only 1-socket virtual machines on a 2-socket server. However, this sizing is also valid for running multiple ESXi servers connected to one Hitachi storage system.

According to <u>SAP Note 3372365</u>, SAP and VMware support a co-deployment of production and non-production virtual machines on the same server. It is also possible to separate the production and non-production SAP HANA virtual machines on different servers but connect both servers to the same storage system.

Non-production virtual machines do not have the same performance requirements as production virtual machines. SAP gives no performance guarantee for non-production SAP HANA installations.

However, in both cases, you must ensure that the production SAP HANA instances and virtual machines are not negatively impacted by the non-production systems running in parallel.

### Guest operating system configuration

The following are supported as guest operating systems for the virtual machines in Hitachi Advanced Server HA820 G3:

- SUSE Linux Enterprise Server for SAP Applications
- Red Hat Enterprise Linux

Changing the configuration settings is only supported according to the guidelines from SAP and the operating system distributor. Otherwise, changes can cause significant performance problems. The following SAP Notes for SUSE Linux Enterprise Server and Red Hat Enterprise Linux are a good starting point for information on this topic:

The initially delivered configuration of the operating system should persist. Do not make any modifications to the operating system, except as noted or approved by SAP.

### **SAP HANA Installation and configuration**

This section describes the SAP HANA configuration on the scale-up configuration for Hitachi Solution for SAP HANA on VMware vSphere.

#### SAP HANA volume configuration for virtual machines

Use the following LDEVs and DP-VOLs for the SAP HANA virtual machine configuration on the Hitachi Virtual Storage Platform system. The following was configured for the engineering testing environment as an example:

- Four 2.6 TB LDEVs to create:
  - Four 256 GB DP-VOLs as VMFSs for SAP HANA data volumes
  - One 1 TB DP-VOLs as VMFS for SAP HANA shared volume
  - One 400 GB DP-VOL to create OS volume
- Four 2.6 TB DP-VOLs to create:
  - Four DP-VOLs as VMFSs for SAP HANA log volumes

The logical volume manager (LVM) configures the SAP HANA persistent storage volumes from virtual machines. With four VMDKs for the SAP HANA log, the LVM creates a single 4-way striped volume on which to create the XFS file system to store the SAP HANA log volumes. Similarly, do this for the SAP HANA data volumes.

For SAP HANA shared, create an XFS file system to store SAP HANA binaries, configuration, and trace files.

#### SAP HANA software installation

After configuring the file system for the SAP HANA data volume and log volume, install the latest SAP HANA Datacenter Service Point (DSP) stack on the SAP HANA server, upgraded to the required SAP HANA revision.

Install the following SAP HANA software components on the SAP HANA node for VMware vSphere server:

- SAP HANA database
- SAP HANA client
- SAP Host agent

# **Engineering validation**

The test methodology for validating the SAP HANA TDI Enterprise Storage configuration with Hitachi Virtual Storage Platform E1090 and ESXi8.u01 used the following.

For TDI solutions, SAP HANA Hardware and Cloud Measurement Tool (HCMT) revision hcmt-074\_0 was tested on the following volumes for RHEL 8.8:

- Data volume
- Log volume
- Shared volume

For TDI solutions, SAP HANA Hardware and Cloud Measurement Tool (HCMT) revision hcmt-074\_0 was tested on the following volumes for SLES 15SP5:

- Data volume
- Log volume
- Shared volume

For optimal use of the system with an SAP HANA database, use the parameters listed in the corresponding appendix for your operating system release. Follow SAP Note 2399079 to set up these parameters defined in the global.ini for SAP HANA 2.0.
